**ACCOMPLISHMENT REPORT**

Calendar Year 2007-2008

The Sangguniang Bayan of St. Bernard is gratified to its Annual Accomplishment Report which viewed their various accomplishments as local legislators in the Municipality of St. Bernard. These accomplishments were geared through their hardwork and timeless effort in rendering remarkable services to the constituents of St. Bernard.

From the period of January to December, 2007, the august body has adopted the Executive-Legislative Agenda (ELA) and likewise the Legislative Agenda (LA). The Annual Action Plan of the Legislative Agenda has set its priority programs for Economic Development on Techno-Demo, Tourism Program and LUB-BDP. Infra-support programs includes Farm-to-Market Roads, Construction of Public Terminal, Improvement of Public Cemetery, Improvement of Water System, Construction of PNP Building, Rehabilitation of Watershed Areas and Rehabilitation of Mangrove, Bird and Fish Sanctuaries. School Buildings, Skills Training, Socialized Housing and Health Programs were also included for Human Development.

Throughout the year 2007, the Legislative Body has enacted Eleven (11) Municipal Ordinances and Eighty Six (86) Resolutions, and conducted Forty Nine (49) Regular Sessions.

From the period of January to December 2008, the Sangguniang Bayan has enacted fourteen (14) Municipal Ordinances which includes Environmental Code, Incentive/Investment Code and Child and Youth Code and passed One hundred thirty one (131) Resolutions, which provide intense impact for the betterment of the community.

In the performance of their basic duties, the Sangguniang Bayan completed Fifty (50) Regular Sessions and conducted Twenty Five (25) Committee Meetings on Barangay Resolutions/Ordinances and Municipal Ordinances for its thorough examination, and two (2) Special Sessions for scrutinizing significant issues in the municipality. Two (2) Joint Sessions were being held at the Brgy. Bolodbolod and Lipanto in order to reach out and extend basic services for the enhancement of barangay governance.

Initiated the Medical/Dental Mission last May 25, 2008, at the ABC Hall of St. Bernard, in coordination with the Philippines Councilor's League, Southern Leyte Chapter.

The august body adopted the Contingency Plan for precaution activities and possible measures in response for the occurrence of Disasters. The continuing Early Childhood Care and Development (ECCD) Work and Financial Plan for CY 2007-2008 was also adopted on May 2008, which includes the priority programs, activities and projects with cost-sharing between the Local Government of St. Bernard and PAGCOR.

Also adopted the Annual Investment Plan CY 2009 which has essentially appropriated One Million Pesos (P1,000,000.00) for the Construction of St. Bernard Public Terminal, and Five Hundred Thousand (P500,000.00) for the Techno-Demo. Due to insufficient appropriation, the august body appropriated P510,167.19 in the Supplemental Budget No. 1 Fiscal Year 2008 and another P320,054.64 in the Supplemental Budget No. 2 CY 2008. The Annual Investment Plan CY 2009 adopted by the Sangguniang Bayan has also appropriated another P1,000,000.00 for the On-going Construction of the Public Terminal.

In connection with the PCL Week, the Sangguniang Bayan explore and executed "Technology Exchange " at Cebu and Bohol Provinces last September 7-9, 2008.

In line with the "Search for the Most Outstanding Sangguniang Bayan" (Local Legislative Award) Southern Leyte Chapter, from the Department of Interior and Local Government (DILG), the Sangguniang Bayan of St. Bernard ranked at the "THIRD PLACE" as an outcome of their hard work and endeavor.

Enacted and Adopted Annual Performance Budget CY 2008 which conforms all the budgetary requirements of this LGU as a 4<sup>th</sup> Class Municipality.

The Sangguniang Bayan of St. Bernard greatly contributes to the implementation of the plans and programs of the Local Government Unit, through their excellent performance in local legislation.
