INVITATION TO RE-BID FOR ***Procurement of Construction Materials for*** ***Construction of Municipal Engineering Office (Phase 2)***

The *Municipality of Saint Bernard*, through the *2010 Municipal Fund*¹ intends to apply the sum of ***One Hundred Seventy Two Thousand Two Hundred Four Pesos and Seventy Three Centavos (PhP172,204.73)*** being the **Approved Budget for the Contract (ABC)** to payments under the contract for ***Procurement of Construction Materials for Construction of Municipal Engineering Office (Phase 2)***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Municipality of Saint Bernard* now invites bids for *Procurement of Construction Materials*.² Delivery of the Goods is required *within 15 days from receipt of the Notice to Proceed*. Bidders should have completed, within *at least six (6) months* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II in the Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from *the Local Government of Municipality of Saint Bernard* and inspect the Bidding Documents at the address given below during *Mondays to Fridays between 8:00AM – 5:00PM*.

A complete set of Bidding Documents may be purchased by interested Bidders on *December 7, 2010* from the address below and upon payment of a nonrefundable fee for the **Bidding Documents in the amount of *One Thousand Seven Hundred Twenty Pesos (PhP1,720.00)***.

¹ In the case of National Government Agencies, the General Appropriations Act and/or continuing appropriations; in the case of GOCCs, GFIs, and SUCs, the Corporate Budget for the contract approved by the governing Boards; in the case of (LGUs, the Budget for the contract approved by the respective *Sanggunian*. (Section 5(a), R.A. 9184)

² A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

Bids must be delivered to the address below on or before **December 22, 2010**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **the ITB**.

Bid opening shall be on **December 22, 2010 at 9:00AM** at **Conference Room of LGU Saint Bernard**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Municipality of Saint Bernard* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
